

#### ON THE WORK OF THE MINISTRY OF JUSTICE OF BOSNIA AND HERZEGOVINA FOR 2011

#### I – OVERVIEW OF THE MOST IMPORTANT ACTIVITIES AND ACHIEVED RESULTS

This report covers the undertaken activities and achieved results of the Ministry of Justice of Bosnia and Herzegovina (hereinafter: MoJ BiH) provided by the **MoJ BiH Programme of Work for 2011**.

**BiH Justice Sector Reform Strategy** (hereinafter: BiH JSRS) was adopted at the end of June 2008, by the Council of Ministers of Bosnia and Herzegovina (hereinafter: Council of Ministers of BiH), Government of the Federation of Bosnia and Herzegovina, Government of the Republika Srpska and Judicial Commission of Brcko District of Bosnia and Herzegovina (hereinafter: JC BD).

At the First Ministerial Conference of the Justice Ministers in Bosnia and Herzegovina and Presidents of the High Judicial and Prosecutorial Council of Bosnia and Herzegovina (hereinafter: HJPC) and JC BD (hereinafter: MC), held in Sarajevo on December 17, 2008, the Action Plan for Implementation of BiH JSRS (hereinafter: BiH JSRS AP) was adopted, which was subsequently amended several times, and there are progress reports on its implementation which are submitted to MC and Council of Ministers of BiH.

**National Strategy for War Crimes Processing in Bosnia and Herzegovina**, though adopted as a separate strategic document, makes a thematic unit and is an integral part of BiH JSRS. Supervisory Board for monitoring this Strategy, established by the decision of the Council of Ministers of BiH, has delivered to the MoJ BiH information on its previous work. Beside that, mechanism of reporting and communicating the MC on progress in the implementation has been established.

MoJ BiH obligations arising from the EU Integration Strategy of Bosnia and Herzegovina, Mid-term priorities of the European Partnership and Stabilization and Association Agreement are contained in the strategic programmes of BiH JSRS and activities provided by BiH JSRS AP, Mid-Term Strategic Plan of MoJ BiH for the period 2009 - 2011 (MoJ BiH MTSP) and MoJ BiH Programme of Work for 2011, and there are progress reports on their implementation which are submitted to the Directorate for European Integrations.

Most of MoJ BiH activities arising from the **Public Administration Reform Strategy and Action Plan 1** are covered by BiH JSRS and BiH JSRS AP, MoJ BiH MTSP and MoJ BiH Programme of Work for 2011, and there are progress reports on their implementation which are submitted to the Public Administration Reform Coordinator's Office.

MoJ BiH MTSP and MoJ BiH Communication Strategy for the period 2009 - 2011 are harmonized with the above mentioned strategic documents and incorporated in MoJ BiH Programme of Work for 2011, and there are progress reports on their implementation which are submitted to the MoJ BiH management.

MoJ BiH is the first institution in BiH which started the implementation of the Uniform Rules for Legislative Drafting in the Institutions of BiH and Regulations on Consultations in Legislative Drafting, when developing policies and normative-legal acts under its jurisdiction, which is regulated by the special Rulebook of MoJ BiH, and there are progress reports on their implementation which are submitted to the Council of Ministers of BiH and Parliamentary Assembly of BiH.

Beside that, MoJ BiH invited civil society organizations (hereinafter: CSO) to engage in monitoring the implementation of BiH JSRS and BiH JSRS AP. Five CSO applied to the public call, and MoJ BiH signed the Memorandum of Understanding with them, so that those CSO have been engaged in monitoring BiH JSRS and BiH JSRS AP from January 1, 2010, and there are progress reports developed in relation to that which are submitted to MC.

#### V - PLANNED AND IMPLEMENTED PROGRAM ACTIVITIES

In MoJ BiH MTSP, it was planned to implement certain number of strategic programmes, which was elaborated in MoJ BiH Programme of Work for 2011.

Strategic objective 1: Contribute further to the strengthening of an independent, accountable, efficient, professional and consistent justice system in BiH, which will also contribute to the creation of preconditions for economy growth in BiH
